**ORDINANCE NO. 2278**

**AN ORDINANCE OF THE TOWNSHIP OF NORTH HUNTINGDON AMENDING  
ORDINANCE NO. 443, AUTHORIZING THE PLACEMENT OF NO ENGINE BRAKE  
RETARDER SIGNS ALONG S.R. 30 BETWEEN MALTS LANE AND BETHEL ROAD**

NOW, THEREFORE, BE IT ORDAINED AND IT IS HEREBY ORDAINED by the Board of Commissioners of North Huntingdon, County of Westmoreland, and Commonwealth of Pennsylvania in accordance with the provisions of the Code of the Township of North Huntingdon being Ordinance No. 443 adopted on October 16, 1975, and as further contained therein in Chapter 131 entitled "Vehicles and Traffic" at Article II entitled "Traffic Regulations" under new Sub-article bearing Section 131-21a entitled "Engine Brake Retarder Prohibitions Established" and as hereinafter set forth:

**SECTION I.** It shall be unlawful for the operator of any vehicle traveling upon S.R. 30 at any of the following segments, in the direction or directions hereby indicating, and in this case specifically to use engine brake retarders as hereby indicated:

EB	30	0060/1715 Bethel Road	0070/0000 Malts Lane
WB	30	0061/1740 Bethel Road	0061/2400 Dollar General Driveway

**SECTION 2.** All Ordinances or parts of Ordinances which are inconsistent herewith are hereby repealed.

**SECTION 3.** If any sentence, clause, section, or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality, or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts of this Ordinance. It is hereby declared as the intent of the Board of Commissioners that

this Ordinance would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part thereof not been included herein.
