This letter is in response to the letter requesting the Department install "no right turn" signs along State Route (S.R.) 0030 at its intersection with Mountain View Place (local road) in North Huntingdon Township, Westmoreland County.

The Department has reviewed this request and the turn restriction is warranted. Mountain View Place is a locally owned roadway, so any signage relating to it shall be installed by the local municipality even if the signage would be within Department right-of-way. Please refer to Publication 212 for more information.

Permission is hereby granted to erect the necessary signs along S.R. 0030. This permission is granted with the understanding that the signs will be properly positioned and maintained in a clear and legible manner. If the signs are damaged, they should be removed or replaced as soon as reasonably possible. It is further understood that the signs will be removed and the Department so informed if changing conditions eliminate further need.

ORDINANCE NO. XXXX

AN ORDINANCE OF THE TOWNSHIP OF NORTH HUNTINGDON AMENDING ORDINANCE NO. 443, AUTHORIZING THE PLACEMENT OF NO RIGHT TURNS FROM STATE ROUTE (S.R.) 0030 TO MOUNTAIN VIEW PLACE

NOW, THEREFORE, BE IT ORDAINED AND IT IS HEREBY ORDAINED by the Board of Commissioners of North Huntingdon, County of Westmoreland, and Commonwealth of Pennsylvania in accordance with the provisions of the Code of the Township of North Huntingdon being Ordinance No. 443 adopted on October 16, 1975, and as further contained therein in Chapter 131 entitled "Vehicles and Traffic" at Article II entitled "Traffic Regulations" under Sub-article bearing Section 131-11 entitled "Left and/or Right Turns Prohibited at Certain Intersections" and as hereinafter set forth:

SECTION 1. It shall be unlawful for the operator of any vehicle traveling upon the first-named highway at any of the following intersections, in the direction or directions hereby indicating, and in this case specifically to make a right turn at said intersections as hereby indicated:

<u>STREET</u>	<u>INTERSECTION</u>	<u>DIRECTION OF TRAVEL</u>
State Route (S.R.) 0030	Mountain View Place	East

SECTION 2. All Ordinances or parts of Ordinances which are inconsistent herewith are hereby repealed.

SECTION 3. If any sentence, clause, section, or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality, or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts of this Ordinance. It is hereby declared as the intent of the Board of Commissioners that this Ordinance would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part thereof not

been included herein.
