ORDINANCE NO. _____

**AN ORDINANCE OF THE TOWNSHIP OF NORTH HUNTINGDON,
COUNTY OF WESTMORELAND, COMMONWEALTH OF PENNSYLVANIA,
AFFIXING VARIOUS TAX RATES FOR THE YEAR 2026.**

**BE IT ORDAINED AND ENACTED, AND IT IS HEREBY ORDAINED
AND ENACTED** by the Board of Commissioners of the Township of North Huntingdon, County
of Westmoreland, Commonwealth of Pennsylvania, that taxes be and the same are hereby levied
on all real property within the Township of North Huntingdon subject to taxation for the calendar
year 2026 as follows:

SECTION 1: Tax rate for General purposes, the sum of 10.73 mills on each dollar
of assessed valuation.

SECTION 2: For Capital Reserve purposes, the sum of 3.0 mill on each dollar of
assessed valuation.

SECTION 3: For Fire Service purposes, the sum of 1.32 mills on each dollar of
assessed valuation.

SECTION 4: For the Water Hydrant District (Ordinance No. 672), for fire hydrant
purposes, the sum of .14 mills on each dollar of assessed valuation. NOTE: This item is applicable
only to properties within six hundred (600) feet of a fire hydrant.

SECTION 5: The following is applicable only to properties located within two
hundred fifty (250) feet of a street light.

A. For the Light District (streetlights – Ordinance No. 668), for streetlight
purposes, \$0.73 per foot for the first fifty (50) feet of improved land, and \$0.20 per foot for each
additional foot of improved land.

B. For vacant lots and unimproved land, the assessment per front foot
for streetlight purposes shall be \$0.20 per front foot.

C. For Ornamental Street Light Districts, the assessment shall be as follows:
